AGREEMENT REGARDING ARCHITECTURAL & ENGINEERING SERVICES OF LAPRAK MODEL SETTLEMENT DEVELOPMENT PROJECT, GORKHA, NEPAL

This agreement is made on the 10th of August, 2016 in Kathmandu, Nepal between:

(Hereinafter called "PARTY"), of the on apart; and

Mrs. Ganga Lamichhane Koney

Arniko Designers & Planners Pvt. Ltd.

(Chief Executive)

(Hereafter called "ADP"), of the second part

Whereas the Party is desirous to have a Master Plan Development Project (hereinafter called "the works") implemented at Laprak, Gorkha and ADP is desirous to provide the architectural and engineering services to undertake the master planning, including all the master planning components as well as the design of the model earthquake resistant house/s, as stated hereunder under the "Scope of Works" to the Party.

Both the parties agree on the following terms and conditions:

CLAUSE 1. SCOPE OF THE WORKS

ADP agrees to provide the necessary architectural and engineering services and deploy the necessary manpower as per the submitted technical proposal to formulate and execute the aforesaid master plan development project, as well as formulate the design of a model earthquake resistant house/s subject to the terms and conditions stipulated and agreed upon by both the parties in the agreement. A brief outline of the scope of the works are as follows:

a. To design and develop Master Plan (MP) for the post-earthquake integrated Laprak village settlement (A sustainable village development plan) and seek approval from National Reconstruction Authority (NRA). The MP should contain detailed architectural and engineering design i.e. structural design, electrical, including solar lighting, sanitary, rainwater harvesting, landscape design, drainage, pavements, roads, community buildings



- etc. and all necessary working details and appropriate 3-D drawings as required for about 600 model houses along with the amenities for a model village at Laprak.
- Designing of the model earthquake resistant house/s complete with architectural plans, including plans, elevations, sections, perspectives as well as working drawings of all architectural, structural, sanitary, electrical (solar lighting), drainage etc. within the budget ceiling and seek approval from the concerned authorities.
- To prepare and submit bills of quantities of both the master plan and the model house/s
- d. The PARTY (NRNA) shall procure all the information regarding the requirements of locals.
- e. The PARTY (NRNA) shall provide the Field Survey Report with all necessary data and survey details.
- f. The PARTY (NRNA) will have to coordinate mutually with ADP as well as the locals of Laprak, Gorkha.

CLAUSE 2. COMMENCEMENT AND COMPLETION OF WORK

ADP shall commence the works on or before 10th August, 2016 and complete the works on or before 22nd September, 2016 or any other time further agreed between ADP and PARTY. ADP shall not be liable for delay in commencement and for completion if the works due to any reason whatever beyond its control.

CLAUSE 3. TERMS OF PAYMENT

- a. The PARTY shall pay ADP a total sum of Five Million rupees including VAT for the
- b. The PARTY shall provide at one time to ADP 30% of agreed amount as an advance payment upon signing of this agreement.
- c. The PARTY shall provide 5% of the total consultancy fee after the submission of inception report within 7 days after signing the contract.
- d. The PARTY will be giving 20% of the total amount after the approval of conceptual Master Plan and preliminary design & drawings within 18 days after signing the contract.
- e. After the approval of pre-final Master Plan, architectural design & working drawings, the PARTY will be handing over 20% of the total fee within 32 days after the contract signing.
- f. On submitting the final Master Plan, architectural design & all working drawings, water supply & sanitation system and electrical design (including solar lighting), street lighting, drainage, road system etc. within 42 days of the contract signing, the PARTY shall be giving 20% of the total fee.
- g. Upon submission and completion of all the bills and quantities and 5 sets of all the documentation, drawings, and approvals related to the master plan and model house/s within 45 days after contract signing, the PARTY will be handing over the rest 5% of the

total consultancy fee.

CLAUSE 4. AGREEMENT MUTAUALLY BINDING

Both the PARTY as well as ADP shall observe and carry out the provisions of this agreement. Should either breach this agreement, the breaching party shall bear the responsibilities, thus caused and compensate losses or damages. Failing to perform one party's responsibilities specified in this agreement will entitle the other party to terminate the agreement whilst the default party pays the financial compensation to be mutually agreed upon.

This contract includes only the scope of work as mentioned in Clause 1. Supervision of the site will be kept, if necessary according to the need of the project (PARTY) by the mutual understanding between the PARTY and ADP.

In witness thereof, both parties here to have signed the agreement on the day, month and year first written above. Two true copies are authorized and signed in the presence of the undersigned witnesses and the agreement comes into force on the day of signature.
