

## Request for Proposal (RFP) for Professional Auditing Services

NRNA invites **Request for Proposal** from licenced Auditing and Accounting firms operating in Nepal, to carry out yearly financial audit for the Fiscal year 2078/2079.

Interested firms and institutions are requested to submit the proposal based on below mentioned scope of work (Part A and B) as below given details.

### **Scope of Work:**

### Part A: Perform a comprehensive external audit (Statutory Tax Audit) of the Association

- Audit of accounts and financial statements maintained by the association
- Report compliance with applicable laws, regulations, accounting standards and policies plans of the association and financial impact on compliance thereof including risk management.
- Design and submit audit plans and procedures for the timely execution of auditing process
- Assess the reliability and sufficiency of the information recorded by the association
- Check whether the relevant information is properly disclosed in the financial statements of the association
- Verification of the transactions, expenditures and procurement process correspond to the budgets as approved by the NRNA Committee
- Verification of the accounting systems in use responds to the needs of association
- Review internal audit report.

#### Part B: Perform Internal Audit as per the financial bylaws of the association

- Review of the accounting and internal control systems
- Examination of financial and operating information of the association
- Review of the economy, efficiency and effectiveness of financial operations including non-financial controls of the association
- Review of compliance with laws, regulations and other external requirements and with management policies and directives and other internal requirements.
- Verification of the transactions, expenditures and procurement process correspond to the budgets as approved by the NRNA Committee
- Verification of the accounting systems in use responds to the needs of association
- Perform the tasks required to ensure the maintenance of proper financial statements and transactions following the internal NRNA bylaws in compliance with the laws of Nepal Government.

- Letter of interest
- Separate proposal for Part A and Part B clearly mentioning the service charges
- Minimum 5 years' experience in auditing of Not Profit Company or Social Organization of similar nature
- Copy of Registration Certificate and renewal, tax clearance certificate etc.
