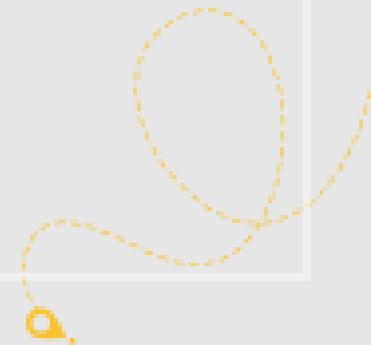

स्टकहोम युरोप क्षेत्रीय बैठकका निर्णयहरू (गैरआवासीय नेपाली संघ एनआरएनए १४ औं युरोप क्षेत्रीय बैठक-२०२२)

२४-२५ सेप्टेम्बर २०२२

गैरआवासीय नेपाली संघ (एनआरएनए) को १४ औं क्षेत्रीय बैठक स्वीडेनको राजधानी स्टकहोममा २४-२५ सेप्टेम्बर २०२२ मा सम्पन्न भयो । शनिबारबाट सुरु भएको २ दिने बैठक प्रमुख अतिथि श्रम, रोजगार तथा सामाजिक सुरक्षा मन्त्रालयका सचिव एकनारायण अर्याल र संघका अध्यक्ष कुल आचार्यले पानसमा बत्ती बालेर संयुक्त रूपमा उद्घाटन गर्नु भयो ।

एनआरएनए अभियानको “रूपान्तरणका लागि कार्यगत साझेदारी” (Partnership in Action, for Transformation) भन्ने मूल नारासहित शुरु भएको बैठकमा श्रम, रोजगार तथा सामाजिक सुरक्षा मन्त्रालयका सचिव एकनारायण अर्याल, अध्यक्ष कुल आचार्य, अर्थ मन्त्रालयका सहसचिव राजेश्वर ज्ञवाली, नेपाल उद्योग वाणिज्य महासंघका वरिष्ठ उपाध्यक्ष एवम् आईएमई गुरुपका अध्यक्ष चन्द्र ढकाल, नेपाली दूतावास डेनमार्कका उपनियोग प्रमुख तिर्थ अर्याल, एनआरएनए आइसिसीका उपाध्यक्षहरू आरके शर्मा, नारायण आचार्य, दुर्गा आचार्य, एनआरएनए युवा उपाध्यक्ष राज रेग्मी, एनआरएनए उपमहासचिव रामशरण सिमरुडा, सचिव जंगाधर गौतम, एनआरएनए मध्यपूर्व संयोजक मनोज श्रेष्ठ गोर्खाली, युरोप क्षेत्रीय संयोजकद्वय चिन्तामणी सापकोटा र सन्तोष भ राई, एनआरएनए अमेरिकाका अध्यक्ष बुद्धि सुबेदी, एनआरएनए स्विजरल्यान्डका अध्यक्ष शुभ प्लमार लामा, एनआरएनए क्यानडाका अध्यक्ष दिपक गौतम लगायत युरोपका विभिन्न एनसिसिका अध्यक्षहरूले शुभकामना मन्तव्य राख्नु भएको थियो ।

कार्यक्रममा एनआरएनए स्वीडेनका अध्यक्ष राजकुमार पाठकले अतिथिहरूलाई स्वागत गर्नु भएको थियो । क्षेत्रीय उपसंयोजकद्वय दयानिधि सापकोटा र डा नवराज रोख्याराले सञ्चालन गर्नु भएको उद्घाटन सत्र एनआरएनए युरोप संयोजक चिन्तामणी सापकोटाको सभापतित्वमा सम्पन्न भएको थियो । क्षेत्रीय युवा संयोजक रमेश काफ्लेले संचालन गर्नु भएको समापन समारोहको अध्यक्षता सन्तोष भ राइले गर्नु भएको थियो ।

बैठकमा गैरआवासीय नेपाली संघको विधान, युवा, महिला र विज्ञहरूका विभिन्न सेसनहरूमा छलफल भयो । त्यस्तै विभिन्न एनसिसीहरूको प्रतिवेदन समेत प्रस्तुत भएका थिए । २० भन्दा बढी देशका करिब २ सय जना प्रतिनिधि सहभागी रहेको सो बैठक विभिन्न निस्कर्ष सहित निम्नानुसारको निर्णयहरू गर्दै सम्पन्न भएको छ ।

१. नयाँ संविधानले गैरआवासीय नेपालीका लागि आर्थिक, सामाजिक र सांस्कृतिक अधिकार उपभोग गर्न पाउने गरी गैरआवासीय नेपाली नागरिकता प्रदान गर्ने व्यवस्था गरेपनि संविधान जारी भएको ठन्डै ७ वर्ष पछि संसदका दुवै सदनबाट पारित भएर राष्ट्रपति समक्ष पुगेको नागरिकता सम्बन्धी विधेयक अघि बढ्न नसकेकोमा आम गैरआवासीय नेपाली समुदायलाई दुःखित बनाएको ठहर गर्दछ । यस विधेयकलाई आम सहमतिको आधारमा मूर्तरूप दिइएर गैरआवासीय नेपाली नागरिकता कार्यान्वयनमा ल्याउन यो बैठक सम्बन्धीत सबैमा हार्दिक अनुरोध गर्दछ ।

२. विदेशमा रहेका नेपालीहरूको पैत्रिक सम्पत्ती तथा मताधिकारको अधिकारलाई सुनिश्चित गर्दै आवश्यक कानूनी व्यवस्था गर्न बैठक नेपाल सरकार र राजनीतिक दलहरूसँग अनुरोध गर्दछ । विदेशमा बसोबास गर्ने नेपाली नागरिकहरूले नेपालको निर्वाचनमा भाग लिन पाउने, मतदान गर्न पाउने अधिकार सुनिश्चित गर्न सम्मानित सर्वोच्च अदालतले समेत निर्देशनात्मक आदेश जारी गरिसकेको परिप्रेक्षमा तत्काल प्रक्रिया मिलाई विदेशमा बस्ने नेपालीहरूको मताधिकार सुनिश्चित गर्न यो बैठक नेपाल सरकारसँग माग गर्दछ ।

३. “Growing Stronger Together with Youths & 2nd Generation” मन्ने नाराका साथ सम्पन्न गरिएको युवा सम्मेलन विशेषगरी युवाहरूलाई उद्यमशील बनाउन जोड दिनु पर्ने र गैरआवासीय नेपाली संघसंग युवा तथा दोश्रो पुस्तालाई अझ प्रभावकारी ढंगबाट जोड्न खेलकूद, भाषा तथा संस्कृतिलाई महत्वका साथ प्राथमिकतामा राखी छुँ बजेट ब्यबस्था गरिनु पर्ने निष्कर्ष निकालेको छ । छिट्टै बृहत् “Global Youth Conference” आयोजना गर्ने निर्णय गर्दै राष्ट्रिय युवा परिषद, नेपाल र गैरआवासीय नेपाली संघबीच नेपालमा युवा परिचालन तथा क्षमता अभिवृद्धिमा साझेदारी गर्ने गरी १२ बुँदे सम्झौता पत्रमा हस्ताक्षर गरी युवा सम्मेलन सम्पन्न गरियो ।

४. आगामी अक्टोबर ११ देखी १३ सम्म हुने एनआरएनए स्थापना दिवस, विधान सभा तथा साधारणसभामा सकृय सहभागिता जनाउन युरोपस्थित सबै राष्ट्रिय समितिहरूलाई यो बैठक हार्दिक आग्रह गर्दछ । साथै गैरआवासीय नेपाली संघको आगामी वर्ष हुने ११ औं महाधिवेशनमा संघको नेतृत्व चयन प्रक्रियालाई सुनिश्चित गर्दै संघको विधानलाई उक्त विधान सभामा सर्वसम्मत दस्तावेजको रूपमा प्रस्तुत गर्न अनुरोध गर्ने निर्णय गरियो ।

५. संघले उद्यमशीलताको विकास गर्न विद्यालयस्तरबाटै “पढ्दै कमाउँदै” जस्ता मौलिक कार्यक्रमहरू संचालनमा ल्याउने योजनाको यो बैठक सहर्ष स्वागत गर्दछ । साथै युवा तथा महिलाहरूको उद्यमशीलता अभिवृद्धिका लागि आवश्यक सहयोग गर्ने, महिला फोरम र युवाहरूको सकृयतामा शुरु भएको सीप विकास तालिमलाई निरन्तरता दिने र गैरआवासीय नेपाली अभियानको हरेक क्षेत्रमा महिला तथा युवाहरूको सहभागिता सुनिश्चित गराउन यो बैठक प्रतिबद्धता जाहेर गर्दछ ।

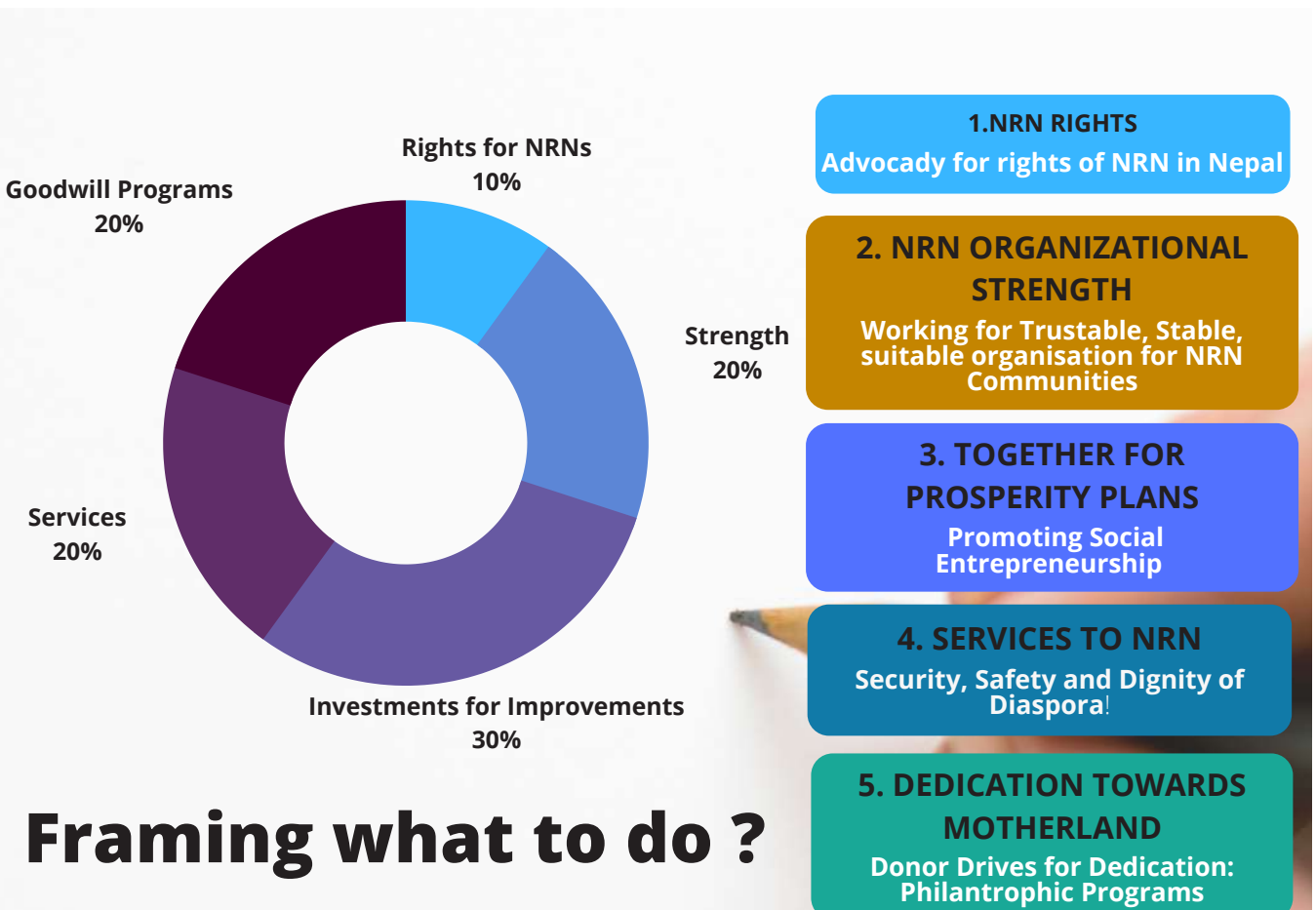
